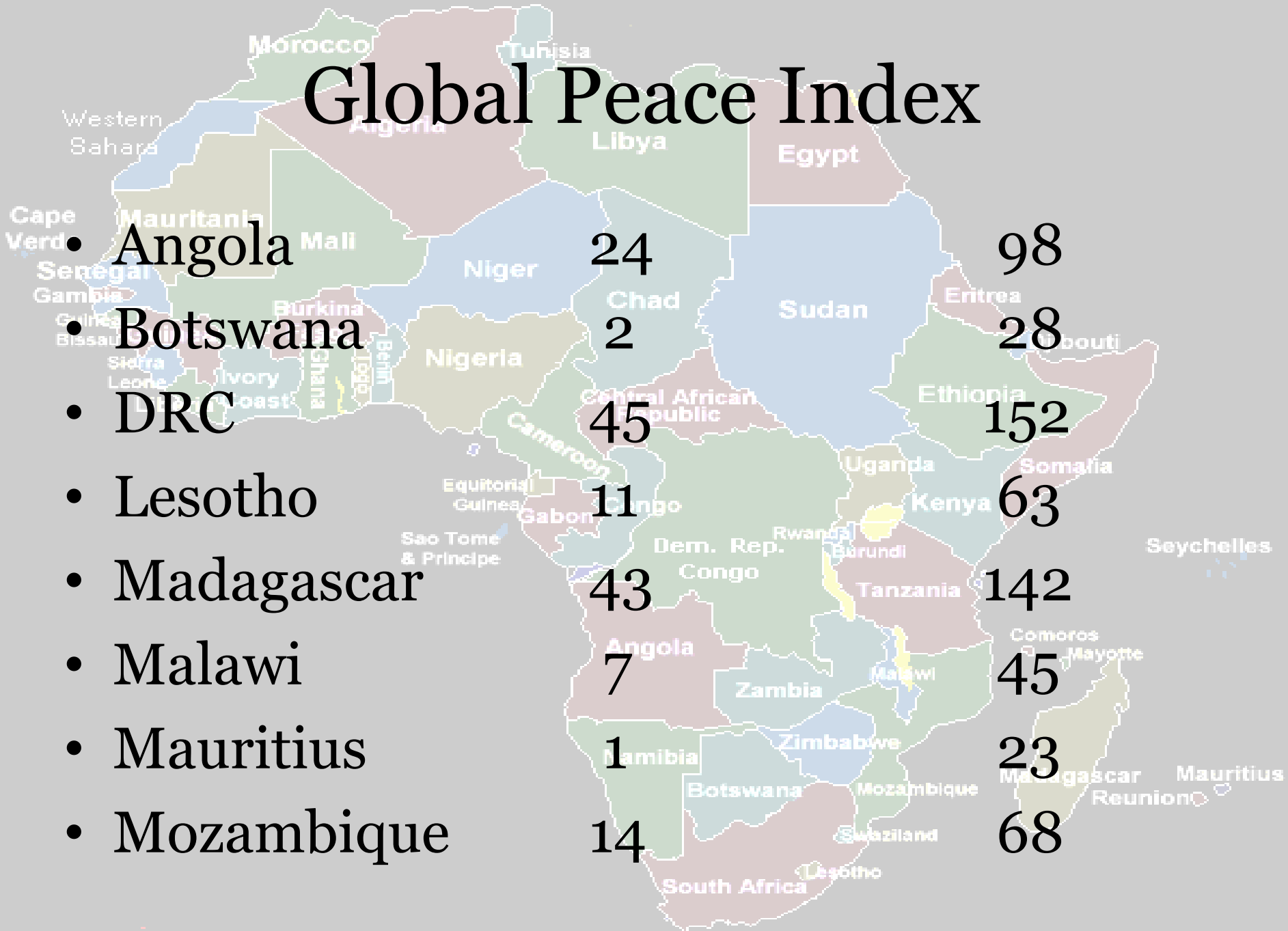

Global Competitiveness Index




